## Refund:

Administrative fees are due with application and are nonrefundable. Annual Fees are due prior to inspection and will be refunded if a request to surrender certification is more than three weeks from an inspection. If a client wishes to withdraw or surrender within three weeks of an inspection 50% of the annual fee will be refunded.

## Inspection:

Inspections are billed as follows:

- Inspection time - \$125 an hour (\$750 max per day)
- Travel Fee – \$50 per hour (\$250 max) and \$.68 per mile.
- Hotel, Meals, Airfare, Gas and any incidentals at local reasonable rates (as applicable).
- Overnight stay - \$100

If an inspection is scheduled and cancelled with less than a week's notice a flat fee of \$350 will be billed.

## Expediting:

Certifications are guaranteed in the following timeline:

- New applications – From the application to scheduling an inspection, within 3 weeks of NFC receiving complete application. From inspection to issuing a certificate, within 5-7 weeks.
- Recert application – From the application to scheduling an inspection, within 2 weeks of NFC receiving complete application. From inspection to issuing a certificate, within 4-6 weeks.

OSP Changes throughout the certification year are guaranteed within 2-3 weeks from submission to approval (barring any issues of missing or wrong documents).

Any request for a guarantee of a shorter timeline will be billed as stated above.

The guaranteed timeline will be agreed upon prior to accepting the application or OSP change.
